Adams a/k/a Tommy Adams, Irene L. Adams, Christopher T. Adams, Mid South Capital Partners LP, Crop Production Services, Inc., The Medical Center at Franklin, Inc., Southern States Simpson Cooperative, Inc., and Simpson County, Kentucky; defendants, I shall sell to the highest bidder at public auction on Friday, October 4, 2019, at the hour of 2:00 p.m., at the Simpson County Justice Center, 101 Court Street, Franklin, Kentucky, the following-described property having as its mailing address 1560 Sloss Road, Woodburn, Simpson County, Kentucky 42170, to-wit:

A certain tract of land located in Simpson County, Kentucky, more particularly described as follows:

Unless stated otherwise, any monument referred to herein as an iron pin set is a 5/8" in. rebar, 18" in. length with a plastic cap stamped "Wheeler #2508". All witness pins set are 5/8"x 18" rebar with a plastic cap stamped witness #2508. All bearings stated herein are rotated to magnetic North.

Beginning on a set iron pin in the North R/W, (25' from C/L) of Sloss Road, approximately 1.0 miles in a westerly direction from the intersection of Robertson Road, corner to Tract 6 of this division, said point being the point of beginning; Thence along the R/W of the road, S 66° 25' 15" W, a distance of 221.68 feet; Thence S 67° 45' 04" W, a distance of 140.58 feet to the point of curvature of a non-tangent curve, concave to the South, having a radius of 559.98 feet a central angle of 04° 53' 05", and a chord of 47.73 feet bearing S 67° 35' 59" W; Thence Southwest along said curve, a distance of 47.74 feet to a set iron pin, corner to Tract 4 of this division;

Thence W/ Tract 4, N 10° 00' 56" W, a distance of 546.16 feet to a set iron pin, corner to Tract 6 and in the line of Tract 4 of this division; Thence W/ Tract 6, N 67° 00' 51" E a distance of 409.96 feet to a set iron pin; Thence S 10° 00' 56" E, a distance of 546.16 feet to the point of beginning; said described tract containing 5.02 acres, more or less, as per survey by Robert K. Wheeler LS #2508, on 02-05-03.

TERMS OF SALE:


